Frozen Semen Breeding Contract - Sold by Dose

THIS AGREEMENT is made between SEAFIRE SPORTHORSES (hereinafter referred to as "STALLION OWNER") and MARE OWNER(s):

With the signing of this contract, the MARE OWNER(s) acknowledge that they have read this Contract in its entirety and agree to abide by all stipulations contained herein:

The stallion chosen for this breeding is: **RICHARD (DECADENT/RAVANELLI) KWPN: 98.03430**

1) STALLION OWNER agrees to provide MARE OWNER with 1) _____ dose(s) of frozen semen and 2) _____ breeding certificate(s) from the above stallion in exchange for a fee of \$_____ (\$400 USD per dose), payable to **STACIA PURCELL**. Fee is payable upon execution of this contract. Fees due to STALLION OWNER can be paid for through PayPal if desired (please notify STALLION OWNER prior to using this option). Any fee payable via PayPal will incur a 3% fee. MARE OWNER specifically agrees and understands that no semen will be shipped until all fees have been paid. Please note: Breeding certificates will be sent in the mail by STALLION OWNER when semen is shipped. **MARE OWNER and their Veterinarian are responsible** for securing and administrating the breeding certificate(s).

2) MARE OWNER understands that the above stallion's semen is collected, frozen and handled by Peterson & Smith, (Phone # 1-352-307-3000). MARE OWNER also understands that additional charges will be made for the handling of the semen, any deposit necessary on the shipping container and the shipping of the semen itself. These charges will be billed by Peterson & Smith or their affiliates. These charges need to be paid by MARE OWNER directly to Peterson & Smith prior to shipment of any semen.

3) MARE OWNER understands that a breeding dose is not to be split or "halved" and one whole breeding dose must be used per insemination. MARE OWNER shall attempt with reasonable diligence to settle mare; if however, for any reason the mare does not settle, mare owner will hold STALLION OWNER and their representative(s) harmless. Any pregnancy resulting from these breedings must be reported to STALLION OWNER by October 1st of year bred so that the mare can be listed on the annual stallion breeding report required for foal registration by the various warmblood registries. Richard is currently licensed/approved with the following registries: ISR/Oldenburger NA, Belgian Warmblood Registry (BWP) and the Continental Studbook. He is activated as an Erkend stallion with the KWPN-NA registry. *Please note: the mare breeding surcharge of \$75 for the KWPN-NA registry is not included in the per dose fee and will be the responsibility of the mare owner should the foal be registered with the KWPN-NA. This fee is due to Seafire Sporthorses upon the mare checking in foal and prior to October 1 of the year bred.*

4) The semen MUST be administered by a licensed Veterinarian familiar with the concept and practical use of frozen equine semen.

5) STALLION OWNER does not guarantee a live foal from the breeding doses contracted herein.

6) MARE OWNER agrees to hold harmless STALLION OWNER their representatives, and/or any semen distribution agents for STALLION OWNER for any injury or illness to mares associated in any way with the insemination of frozen semen provided by STALLION OWNER. MARE OWNER specifically understands that STALLION OWNER makes no guarantees or warranty as to the fertilizing capacity of any semen provided under the terms of this contract, either expressed or implied, however, known conception rates will be relayed to MARE OWNER, and are given in good faith. MARE OWNER is responsible for ascertaining their mare's Registry's requirements for the use of frozen semen and subsequent registration of foals conceived thusly. STALLION OWNER is not responsible for any fees or moneys due associated with the breeding of MARE OWNER's mare(s). This contract, constitutes the entire agreement between the parties hereto and may not be modified except in writing and signed by all parties hereto. This Contract may not be assigned or transferred by any of the parties hereto without the consent of the other. This Contract is made and entered into in the State of Florida, and shall be enforced and interpreted in accordance with the laws of said State. All action with respect to this agreement will be instituted in a court sitting in St John's County, Florida, and the MARE OWNER(s) irrevocably and unconditionally submits to the jurisdiction (both subject matter and personal) of such court and waives any objection to the venue in such court and waives any claim that any actions have been brought in an inconvenient forum. This contract shall be binding upon the parties hereto and their personal representatives.
